



Zero Tolerance Policy

Effective January 1, 2014



Welcome to the Little Kalamazoo Speedway Quarter Midget Club! We are very proud of our facility, race track, club officials, members, and our "family" atmosphere. To ensure that your family's experience here is a positive one, we have instituted a "Zero Tolerance" Policy. Please review the violations below and make sure that everyone associated with your race team is familiar with them. This policy will be strictly enforced and the LKSQMC Board of Directors & LLC Owner will make all decisions. All appeals will be determined by the LLC Owner, President & Vice President.

*Suspension Terms

	Violation/Action	Suspension Term*
1	Deliberately damaging, destroying or defacing LKSQMC property and facility	Up to 1 year plus cost of damages
2	Being under the influence of drugs or alcohol during racing conditions (ie. Driver/handler meeting to tech completion)	Up to 6 months - 180 days
3	Making any physical threat or contact to any person at the LKSQMC facility (including drivers)	Up to 6 months
4	Throwing object in pit area or hot chute	Up to 2 race weekends
5	Ignoring instructions from a track official (driver)	Up to 1 month
6	Ignoring instructions from a track official (Handler)	Up to 1 month
7	Violating LKSQMC Rules and Regulations - Including, but not limited to, smoking in non-designated areas, violating LKSQMC practice policy.	Minimum 1 race weekend
8	Excessive yelling, comments or obscenities directed at a track official, judge, handler or driver	Up to 1 month
9	Any Social media posts listing the track, or any track official, a family name, or driver name, pictures or video criticizing any of the above	Up to 1 month
10	Driver making an obscene hand gesture to a track official	Done for the day and DQ from class (Note: Driver Only)
11	Any disrespectful conduct toward the chief steward and/or race official	Done for the day and DQ from class (Driver and Handler)

- LKSQMC Board or LLC Owner can choose to suspend member, driver, and/or handler at its discretion
- All driver suspensions are for the individual driver only
- All suspension terms begin the following race date on the schedule or as noted above
- All suspensions will be approved by Board of Directors & then approved by LLC Owner
- Suspension term will be determined by the Board Members & then approved by LLC Owner
- Suspension term can carry over to next calendar year
- Multiple violations/actions within a 12 month period may receive a suspension term
- All suspension terms may be adjusted due to the severity of the violation by the Board of Directors & LLC Owner
- Written Notification of Suspension term will be sent
- Appeals must be received in writing within 7 days of receiving written suspension notification
- Any DQ or suspension in reference the ZTP will not be allowed to be used as a "drop" in point
